



Declaration of Commitment to the CSA Awareness Programme

Section I

I agree to:

- 1) Commit time and energy to the workshop and practical training for the ‘Certified Trainer on Child Sexual Abuse (CSA) Awareness’.
- 2) After the successful completion of the ‘Certified Trainer on CSA Awareness’ workshop, I agree to conduct CSA awareness workshops in Mumbai schools allotted to me for CSA awareness.
- 3) In every school, I will conduct sessions in every division from standards 2nd- 6th in one go. I understand the assumption that of 4 divisions in each standard implies 20 sessions of 35-40 minutes duration, per school.
- 3) I will use my role as a Child Protection Ambassador in my neighbourhood to spread awareness about the need for Child Protection amongst children and adults.
- 4) I agree to work with CHILDLINE India Foundation (CIF) in conducting the workshops and understand that a capsule on the 1098 service will be included in all my sessions.
- 5) I understand that the ‘Letter of Authority’, provided by CIF at the end of the 3 day workshop has a validity period of a year, which can be extended by participation in refresher courses as and when organised. I agree that the ‘Letter of Authority’ will be given to me at CIF’s discretion.
- 6) I also agree to come back for refresher courses as and when set up by CIF.

Section II

I have read and understood the CIF Child Protection Policy, which is applicable to CIF and all its partners and agree to abide by the policy.

Section III

I agree to abide by the rules and regulations of the schools where I conduct workshops and will maintain the highest level of safety standards. I also agree to adapt and design



the content of the CSA awareness workshops keeping in mind the requirements of the children and in consultation with CIF and the school authorities.

Section IV

I understand that the ‘Certified Trainer in Child Sexual Abuse Awareness’ certificate provided at the end of the committed number of schools is not a professional qualification that can be listed as a degree or a diploma. I also understand that the certificate only states that I have participated in a workshop, which has helped me with some skills and techniques required to conduct CSA awareness workshops in schools for children and adults.

Section V

I will communicate regularly with the CSA project team in CIF and participate in meetings with schools and education societies as and when organised. I also agree to visit the CIF office regularly and file reports after completing each school.

I have read and understood the terms of the ‘Declaration of Commitment to the CSA Awareness Programme’ and agree to abide by the same. I agree to abide by CIF’s Child Protection Policy fully and understand that my continuance as a Child Protection ambassador is at CIF’s discretion. I will extend whatever co-operation possible to CIF for ensuring that the programme runs smoothly.
